Legal Assistance

Offering Veterans Free Legal Assistance

The Montgomery County Veterans Service Commission is offering Veterans free legal services. The commission is the first of Ohio's 88 county Veterans Service Commissions to offer such services to Veterans.

This service will provide free consultation and advice to all Veterans who request assistance. Currently legal representation is limited to: housing issues, debt collection, administrative law issues, estate planning such as last wills and testaments, and power of attorney documents.

While the Veterans Legal Counsel position cannot provide representation in all matters or situations, all Veterans are welcome for a free legal consultation. The Veterans Service Commission and Attorney Strain are excited and honored to provide this new resource to Veterans in the community.

Veterans do not have to live in Montgomery County to receive legal help. Veterans can call the commission office at 937-225-4801 to set up an appointment with the commission's legal counsel attorney, Steven Strain.

VA National Cemetery Burial Benefits

Application for Pre-Need Determination of Eligibility for Burial in a **VA National Cemetery**

Do you want to ensure that a final resting place for you, your spouse and even your dependent children is addressed before your passing? Burial benefits available include a gravesite in any of our national cemeteries with available space, opening and closing of the grave, perpetual care, a government headstone or marker, a burial flag, and a Presidential Memorial Certificate, at no cost to the family. Some Veterans may also be eligible for Burial Allowances. Cremated remains are buried or inurned in national cemeteries in the same manner and with the same honors as casketed remains.

The Pre-Need Burial Application will help your service be honored in the manner you wish prior to the time of need.

If a Veteran would like to make pre-need arrangements and needs assistance in filling out the Pre-Need Application (VA Form 40-10007) please contact our office. Our Veteran Service Officers will do their best to ensure you fully understand this benefit.

Opportunity to Help Fellow Veterans

Volunteer Mentor Program

Mentors provide support to Veterans engaged in the Veterans Treatment Court (VTC). The VTC gives Veterans involved in the justice system an opportunity to seek treatment for underlying issues which led to their involvement with the court. The mentors are typically Veterans themselves that will act as a role model, coach, guide, and advocate for the Veteran they are mentoring. They will work closely with the presiding Judge (Honorable Dennis Adkins), the VA Veterans Justice Outreach Coordinator and other court personnel. Mentors will assist VTC Veterans with navigating their recovery process through the VA and other resources.

This program is critical to the success of the Veterans Treatment Court and more importantly to the success of our Veterans. This program gives Veterans a second chance to move forward in life.
